RESOLUTION

WHEREAS, Government Code section 31452.5 authorizes the Retirement Board to give effect to a revocable written authorization signed by a retired member or beneficiary of a retired member entitled to a retirement allowance or benefit to deduct a specified amount from the retirement allowance or benefit payable for a variety of allowed purposes; and

WHEREAS, Government Code section 31452.5(a)(3) authorizes a deduction for premiums for a vision care program or dental plan, approved by the board, for the benefit of the retired member or his or her dependents; and

WHEREAS, the State Association of California Retirement Systems (SACRS), of which FCERA is a member, has contracted with Vision Service Plan (VSP) to offer a vision care plan to retired members and their beneficiaries; and .

WHEREAS, the State Association of California Retirement Systems (SACRS) has contracted with CIGNA Healthcare (CIGNA) to offer a dental plan to retired members and their beneficiaries; and

1 **WHEREAS**, the Retirement Board wishes to make these programs available to retired
2 members and their beneficiaries of the Fresno County Employees' Retirement Association
3 (FCERA);

4 **NOW, THEREFORE BE IT RESOLVED** that the Board of Retirement of the Fresno County
5 Employees' Retirement Association hereby authorizes retired members of FCERA, or
6 beneficiaries of retired members entitled to retirement allowances or benefits from FCERA, to
7 direct payment of premiums for the acquisition of vision care services and/or a dental plan
8 offered by SACRS upon delivery of a revocable written authorization signed by the member or
9 beneficiary to FCERA; and that such revocable written authorization will be maintained by
10 FCERA.

12 **AND, THEREFORE BE IT FURTHER RESOLVED** that the Board of Retirement of the Fresno
13 County Employees' Retirement Association hereby directs that such deductions will be allowed
14 without additional charge by FCERA to the members or beneficiaries requesting the deductions,
15 subject to further review and action by the Board of Retirement.


