Fiscal and Financial Impacts

There are no known financial impacts to receive and file this Budget Status.

Background and Discussion

The attached report (Exhibit A) represents the Retirement Association's Fiscal Year 2021-22 Administrative Budget status, on a cash basis at December 31, 2021. This report is prepared on a quarterly basis to inform the Board on the progress of the Administrative Budget for the current fiscal year.

The Administrative Budget includes appropriations for Salaries and Benefits, Services and Supplies, and Capital Improvements. Under Exhibit A, the total expenditures reported as of December 31, 2021 were 33% of the adopted Administrative Budget limit set by the Board of Retirement. Salaries and Benefits were 40% of budgeted appropriations, while expenditures for Services and Supplies were 22% of budgeted appropriations. Both categories came in below expected expenditures of 50% of budgeted due to salary savings, from vacancies, and the timing of quarterly billings, respectively.
