## Fiscal and Financial Impacts

There are no known financial impacts to receive and file this Budget Status.

## Background and Discussion

The attached report (Exhibit A) represents the Retirement Association's Fiscal Year 2022-23 Administrative Budget status, on a cash basis at March 31, 2023. This report is prepared on a quarterly basis to inform the Board on the progress of the Administrative Budget for the current fiscal year.

The Administrative Budget includes appropriations for Salaries and Benefits, Services and Supplies, and Capital Improvements. Under Exhibit A, the total expenditures reported as of March 31, 2023 were $53 \%$ of the adopted Administrative Budget limit set by the Board of Retirement. Salaries and Benefits were 59\% of budgeted appropriations, while expenditures for Services and Supplies were $43 \%$ of budgeted appropriations. Both categories came in below expected expenditures of $75 \%$ of budgeted due to salary savings and timing of quarterly billings, respectively.
